#### Insurance:

Property Damage Motor Vehicle Accident in parking lot involving FF Billy Gasser POV.

Date: 4/4/22

Time: Between 19:00-21:00

Member Billy Gasser returned from the regular Monday evening drill to find his POV had been hit presumably by another vehicle causing damage to the driver's door Apillar. The damage resulted in the driver's door not being able to be opened without causing further damage to the door or front fender. Chief 70 notified the Ontario Co. 911 center via radio and requested a deputy to respond to take a report. Chief 70 also contacted all personnel who attended the drill inquiring if anyone had witnessed or knew anything about the accident? These contacts were done on the Chief's personal cell phone. Members were unable to provide any information, and no members witnessed the accident.

After discussing the incident with the deputy, Gasser declined a police report be taken as his personal insurance would likely not cover the incident. Gasser stated he would have the repairs done at his own expense. Chief 70 did not report the incident to the BOFC because there was no accident report taken, no witnesses and no way to determine who was at fault.
