Procurement: Commissioner Duvall has a potential candidate for the procurement job. His name is Cassidy Mincer, and he currently works at the VA. He is interested but wants to know more about the role and compensation.

-The board agreed whoever takes on this role should come to every meeting. And be in communication with the Chief often for the department needs.

-Chairperson Heissenberger wondered if a flat rate should be done or more based on job performance. He suggested \$150 a month.

-Commissioner Rhoda suggested an estimate of 15 an hour but with the hours it could be several thousand over the year and he said this role should not be paid more than the secretary.

-Commissioner Legters reminded this role will have to be budgeted for so the taxes can still be kept low.

-This job opportunity as well needs to be posted with a job description. Chief Koppmann suggested to reach out to Pinsky to see what legally needs to be done.

-Commissioner Legters and Commissioner Duvall will continue to work on.

-Commissioner Rhoda wanted to add in the Website/Camera committee to be worked on still, domain name has been purchased. Nothing heard from Pinsky for more information on this.

Buildings: Commissioner Rhoda is still waiting to hear back from Carl.

-Generator has been maintained.

-Window replaced and Commissioner Rhoda mentioned it may be free of charge from what he is led to believe.

-West Fire mentioned a door strike needs to be replaced and they will help with keypad, fixing the wiring. They have parts from other keypads to do this repair.

-Down to 6 bags of salt and Commissioner Rhoda will order.

-Red Cross wants to be here about every 8 weeks for the blood drive. They are running out of options at other locations. Mainly due to volunteers they said. -Discussion on fob or pin pad number to be given to them for the needs. -Commissioner Rhoda asked if it is possible to program a number on each visit, and then when close to the date he can give it to the contact he has. -Board discussed how fob may not be the best if people change. Commissioner Legters can program it with a number to change each time.

-Chiefs office door if not always locking. He has to pull harder on it to close. Commissioner Legters to reach out to West Fire.

-Where 712, and 741 are parked, there are bubbles in the epoxy or flaked off or gone. Commissioner Rhoda to reach out to C.A. Reed.

-They are right in front of truck tires.

-Circulation pump: nothing about Ryan fixing. Commissioner Rhoda to reach out.

Grounds: Commissioner Duvall is going to work on criteria for snowplow contracts. This needs to be sorted out by next month to place a public bid announcement.

-Chairperson Heissenberger wonders if zero tolerance policy would be good. -Commissioner Duvall did say to be careful about budgets. And to plan for major price increases due to fuel costs and salt costs. A bag which used to cost \$2.99 is now over \$6.00

-They need to be fully insured.

-Commissioner Rhoda said dead tree in back. To confirm its on our side of the property the board hopes the survey will help.

Insurance: There has not been many complaints in regard to the community room needing to have an insurance policy Commissioner Rhoda shared.

-The only issue Commissioner Rhoda has come across is some community members just may not know how to add the insurance for the event.

-There is a hold harmless agreement, and deposit already in place. -Commissioner Kachmaryk shared that the insurance agent Joel Steele said if there are any issues with room damage it would be more then the deposit and there would need to be communication to the renters insurance.

-If damage is done it could then potentially punish the community member who want to rent the room in the future depending on times of repairs.

-Chairperson Heissenberger shared that in the past many things had been taken before. It included pots, pans and even someone's butcher block.

-Commissioner Duvall makes a motion to remove insurance rider policy from the room rental policy. Seconded by Commissioner Rhoda.

-Discussion open.

-Member of the fire department and past commissioner Vic Rauscher shared that due to the lack of insurance on the room by the individual it will then require a larger deposit.

-Commissioner Kachmaryk also agreed the deposit has to increase.

-Commissioner Rhoda wondered if a deposit of \$500 would work but then many community members may not be able to do that.

-Commissioner Legters was worried about check bouncing in general. This would then result in the district getting charged by that bank as well.

-Commissioner Rhoda did bring up that Boy Scout Den leaders want to use the room monthly. They are running out of places to hold their meetings.

-However, insurance on the room might be easier as the renter then may feel more liable Commissioner Kachmaryk added.

-The board wonders what other places charge in town. Commissioner Kachmaryk did share it was very expensive to even use a soccer field at Veterans Park.

-Many groups wanting to use room may have group coverage already.

-Chairperson Heissenberger did bring the motion back to question to place a vote.

-Reminder motion was made by Commissioner Duvall to remove insurance rider policy from the room rental policy. Seconded by Commissioner Rhoda.

New Business: Neighbor across the street is getting their driveway repayed and would like to use a parking spot while it is being worked on. District ok with this but requests they park in the back and keep the front spots open for the fire department members.
